MONTHLY REPORTS

4-H/Youth Program Advisor, Jodi Loehrer, updated the Board on the following items: Achievement days, a 4-H bake and produce sale is scheduled to be held at Joy Ranch in conjunction with the 125th Celebration of the State of South Dakota's statehood, horticulture requests for information are coming in, pressure canner training for office staff is scheduled, and preparations are underway for the upcoming South Dakota State Fair. **Auditor, Cindy Brugman,** reported the 2015 Provisional budget is scheduled for publication and 2014 General Election ballot preparation is underway. **Director of Equalization, Shawna Constant,** reported the Dept. of Revenue has conducted a mid-year audit of her office, 3/4 of the field work in the reappraisal area has been completed, clerical staff will attend a software user's meeting, the Director and appraisal staff will attend annual schooling, and Agricultural productivity numbers have been received from the Dept. of Revenue with crop values going up approximately 15% and non-crop values less than a 5% increase.

Motion by Johnson, second by Hanten, to authorize Facilities Manager, Milo Ford, to sign a concurrence form regarding a Section 4(f) finding, from the SD DOT, that the proposed bike path to run through the Memorial Park campground will enhance the current use of Memorial Park; all present voted aye; motion carried.

FUNDING AGREEMENT ADDENDUM BETWEEN THE COUNTY AND CITY

Motion by Hanten, second by McElhany, to approve an addendum to the memorandum of agreement, dated March 20, 2012, between Codington County and the City of Watertown for the distribution of the funds received under the Memorandum of Agreement between the Sisseton-Wahpeton Oyate Sioux Tribe, Codington County, and the City of Watertown for fire, law enforcement, ambulance, and road services at Dakota Sioux Casino. This agreement would provide for two annual payments, in 2014, from the Tribe, in the amount of \$75,000.00 each, which would then be split \$50,000.00 to the County and \$25,000.00 to the City, for each payment during the one year term of the Agreement. Upon vote of the Board; all present voted aye; motion carried.

GENERAL OBLIGATION BONDS RESOLUTION

RESOLUTION NO. 2014-18

A RESOLUTION DECLARING NECESSITY AND EXPEDIENCY FOR ISSUANCE OF GENERAL OBLIGATION BONDS, CALLING AN ELECTION THEREFORE AND HIRING PROFESSIONALS IN CONNECTION THEREWITH.

WHEREAS, Codington County (the "County") hereby finds it necessary to pay for the construction of a new justice center including a jail facility, court rooms and offices for County and State employees and the furnishing and equipping of the same and the renovation of the existing court house (the "Improvements"), if so approved by the voters; and

WHEREAS, the County is authorized to issue bonds pursuant to South Dakota Codified Laws Chapter 7-24-1 to finance Improvements; and

WHEREAS, pursuant to South Dakota Codified Laws Section 6-8B-3 no bonds may be issued unless authorized by a vote of the people.

BE IT RESOLVED by the County Commissioners of Codington County, South Dakota, as follows:

- 1. <u>Declaration of Necessity.</u> It is hereby found, determined and declared that it is necessary and expedient for the County to borrow money by issuing its general obligation bonds in an amount not exceeding \$35,000,000.00 payable from 1 year and not to exceed 20 years from date of issuance, bearing interest payable at such times and at such rate or rates as may be determined by the County Commission, for the purpose of financing the Improvements, if so approved by the voters.
- 2. <u>Election.</u> The question of authorizing the issuance of such bonds shall be submitted to the qualified electors of the County at a bond election which is to be held on November 4, 2014 between the hours of 7:00 o'clock a.m. and 7:00 o'clock p.m. The question shall be in substantially the following form:

SHALL CODINGTON COUNTY, SOUTH DAKOTA, ISSUE ITS NEGOTIABLE GENERAL OBLIGATION BONDS IN A REGISTERED PRINCIPAL AMOUNT NOT EXCEEDING \$35,000,000.00, ISSUED IN ONE OR MORE SERIES, BEARING INTEREST AT SUCH RATES AS MAY BE DETERMINED BY THE COUNTY COMMISSION, PAYABLE AND MATURING FROM 1 YEAR AND NOT TO EXCEED 20 YEARS AFTER THE DATE OF ISSUANCE, FOR THE PURPOSE OF FINANCING A NEW JUSTICE CENTER INCLUDING A JAIL FACILITY, COURT ROOMS AND OFFICES FOR COUNTY AND STATE EMPLOYEES AND THE FURNISHING AND EQUIPPING THE SAME AND THE RENOVATION OF THE EXISTING COURT HOUSE.

SHALL THE ABOVE PROPOSITION BE APPROVED AND THE BONDS ISSUED?

- 3. <u>Polling places and Judges</u>. Polling places and judges and clerks for said election shall be selected according to South Dakota Law.
- 4. <u>Voter Registration Deadline.</u> The County Auditor is hereby authorized and directed to give notice of voter registration and deadline therefore, as required by law. The deadline for voter registration shall not be less than fifteen (15) days prior to the election. The County Auditor shall give notice of the availability of registration officials and state when registration will be terminated and the effect of a failure to have registered. Such notice shall be published in official newspapers of the County at least once each week for (2) two consecutive weeks, the last publication to be not less than (10) ten nor more than (15) fifteen days before the deadline for registration.
- 5. <u>Notice of Election.</u> The County Auditor is hereby authorized and directed to give notice of bond election, said notice to be published in the official newspaper for the County, once each week for two (2) successive weeks before said date of election. The second notice shall be published not less than four (4) days nor more than ten (10) days before the election.
- 6. <u>Ballots.</u> The County Auditor is authorized and directed to cause printed ballots to be prepared for use at said election in substantially the form on file with the County Auditor and to publish with the second notice of election.
- 7. <u>Canvass.</u> Said election shall be held and conducted and the votes cast thereat shall be counted, certified and canvassed according to law, and this County Commission shall meet at the regular meeting room in the Codington County Courthouse, Watertown, South Dakota, in the County for the purpose of canvassing the results within six (6) days of the election.
- 8. <u>Hiring of Professionals.</u> Dougherty & Company LLC is retained as financial advisor and Lindquist & Vennum LLP is hereby designated as bond counsel for this issue. The Chairman of the County Commission and County Auditor are authorized to execute such documents as are necessary to carry out the intent of this paragraph.

County Commissioner Tyler McElhany moved for the adoption of the foregoing Resolution. Said motion was seconded by County Commissioner George Heller and upon vote being taken the following voted AYE: George Heller, Tyler McElhany, Myron Johnson, Elmer Brinkman, and Brenda Hanten; and the following voted NAY: none voted NAY; whereupon said motion was declared duly passed and adopted, and was signed and attested by the Chairman and County Auditor.

JUSTICE CENTER BUILDING PROJECT

GOOSE LAKE ROAD SIGNS

Highway Supt., Rick Small, met with the Board to recommend a change to the road closed signs currently in place at the intersection of 177th St. and 446th Ave on the south side of Goose Lake. Currently sportsmen who access the lake at this point to fish are parking vehicles and trailers which are blocking an approach used by an agricultural producer to access his field. Mr. Small recommended removing the road closed sign currently in place with a sign indicating the road is closed to through traffic along with no parking signs to keep the field access clear. These signs will then legally allow the agricultural producer to access his field and the sportsmen to access the lake. The Board concurred with the new signage as recommended by the Highway Supt.
