ORDINANCE #13A AMENDED

The Board held the second reading and a public hearing to amend Ordinance #13A, an ordinance to prohibit open burning in Codington County. Chairman Brinkman opened the public hearing and asked for comments from the public sector present for this meeting; no comments were offered and the

Chairman closed the public hearing at this time. Moved by McElhany, second by Hanten, to approve Ordinance #13A as amended; all present voted aye; motion carried.

LAW LIBRARY DIGITAL SUBSCRIPTION CONTRACT

Motion by Gabel, second by McElhany, to authorize the Chairman to sign a 2 year contract with Thomson Reuters for a digital Law Library subscription. Commissioner Gabel informed the Board the cost for this subscription will be \$234.50 per mo. for one year and will increase to \$248.57 in 2017 with funds for the subscription coming from the County's Law Library Trust and Agency Fund. This subscription will provide public access to a Law Library via computers at the Watertown Regional Library. Upon vote of the Board; all present voted aye; motion carried.

AUTOMATIC BUDGET SUPPLEMENT

Motion by Hanten, second by McElhany, to supplement the Government Buildings budget in the amount of \$2,778.00 with grant reimbursement funds for a court security project; all present voted aye; motion carried.
