The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, October 28<sup>th</sup>, 2014, at the Codington County Courthouse. Commission members present were: George Heller, Tyler McElhany, Myron Johnson, Elmer Brinkman, and Brenda Hanten; Chairman Brinkman presiding.

#### AGENDA APPROVED

Motion by Hanten, second by Heller, to approve the agenda, all present voted aye; motion carried.

#### MINUTES APPROVED

Motion by Johnson, second by Heller, to approve the minutes of October 21<sup>st</sup>, 2014; all present voted aye; motion carried.

# **HYVEE FOOD STORE HOLIDAY SHOWCASE**

Kim Nichols, restaurant manager for the Market Café at HyVee Foods Store, met with the Board to request authorization to sample alcoholic beverages at Hy-Vee's Chamber Holiday Showcase to be held at the Codington County Extension Center Complex on November 13, 2014 at 5:00 P.M. Motion by Johnson, second by Hanten, to approve the request as presented by Ms. Nichols; all present vote aye; motion carried.

#### MONTHLY REPORTS

Emergency Management Director, Jim Sutton, reported he will assist with the deliver and pick up of election equipment for the Auditor's Office, a Regional Emergency Management meeting is scheduled for November 3<sup>rd</sup> in Watertown, the South Dakota Safety Conference will be November 12<sup>th</sup> & 13<sup>th</sup> in Pierre, an Emergency Management IMAT meeting will be held in Pierre on November 17th, the LEPC meeting is scheduled for November 18th, and Mr. Sutton will be available on November 20th for a Safety Benefits review. Mr. Sutton noted the Search and Rescue team has recently assisted local law enforcement with cases in Watertown. Discussion was also held on safety measures to contain the spread of contagious/infectious diseases. Sheriff, Toby Wishard, submitted the following statistics for the month ending September 30<sup>th</sup>, 2014, for the Detention Center and Sheriff's Office: Average daily inmate population 65.27; bookings 218; \$12,359.00 collected in fees for out of county prisoner contracts; \$11,940.00 collected in work release fees; \$2,930.00 collected in fees for the 24/7 program, \$3,689.00 collected in SCRAM fees, which were remitted to the Office of the SD Attorney General; 43 individuals testing twice daily for PBT's; 5 individuals reporting twice weekly for UA Drug testing; and 21 individuals wearing SCRAM (security continuous remote alcohol monitor) bracelets; 543 cases/calls for service; 6 traffic accidents investigated; 126 arrest warrants were served; 261 sets of civil papers served; and 21 prisoner transports conducted with 5,565 miles traveled. Sheriff Wishard presented the Board with a report of fees, collected and retained by the County, in the month of September 2014, in the amount of \$6,754.45. A discussion was held regarding the use of the Human Service Agency "safe room," mental illness transports, and the impact on County budgets and staff time.

# **BRIDGE REPLACEMENT PROJECT #15-215-230**

Highway Supt., Rick Small, met with the Board to discuss County bridge #15-215-230 which the SD DOT previously declared eligible for replacement funds due to its low sufficiency rating (see Commission minutes from June 17, 2014). Mr. Small advised the Board the cost to replace this bridge is approximately \$625,000.00 with an obligation to the County of \$125,000.00. Mr. Small noted that within a master transportation study, of which the County recently participated, mention was made as to whether or not this bridge, and two others in the vicinity over the Sioux River, are all necessary. Mr. Small noted this bridge has a low volume of traffic and the cost for the public using the bridge, to reroute to the next mile road, would be approximately \$5,300.00 per year. The cost to rehab the bridge, own and operate would cost the County approximately \$11,000.00 per year for 75 years. The recommendation from the master transportation study was to close the bridge when the sufficiency rating reaches the low point which could be 15 to 20 years from now. There are no load limits on the bridge at this time and the sufficiency rating is 47.8%. The bridge is located on 178<sup>th</sup> Street one mile north of the southern Codington County line. Motion by Hanten, second by Johnson, to authorize the Chairman to sign a work order to proceed with the bridge replacement project; upon roll call vote; Heller voted no, McElhany voted no, Johnson voted no, Brinkman voted no, and Hanten voted no; motion failed.

# AUTOMATIC BUDGET SUPPLEMENT

Motion by Hanten, second by Heller, to supplement the Road & Bridge Budget with SD DOT reimbursement funds in the amount of \$102,854.37 for the County Road 20-3 project; all present voted aye; motion carried.
