January 14, 2020

The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, January 14, 2020, at the Codington County Courthouse. Commission members present were: Lee Gabel, Charlie Waterman, Myron Johnson, Troy VanDusen and Brenda Hanten; Chair Brenda Hanten, presiding. Commissioner Gabel led the pledge of allegiance.

CONFLICT OF INTEREST ITEMS

There were no conflict of interest items to note.

CALLS FOR PUBLIC COMMENT

Chair Hanten called for public comments for the Open, none were forthcoming.

AGENDA APPROVED

Motion by VanDusen, second by Gabel, to approve the agenda as posted; all voted aye; motion carried.

MINUTES APPROVED

Motion by VanDusen, second by Gabel, to approve the minutes of January 7, 2020; all voted aye; motion carried.

INTER-LAKES COMMUNITY ACTION PROGRAM REPORT

Cindy Dannenbring, Executive Director, Inter-Lakes Community Action; met with the Board to give a report of ICAP services provided to low-income and older residents in Codington County from August 2018 through July 2019, including the following: Weatherization services were provided to 10 homes; furnaces repaired or replaced in 11 homes; 40 children received Early Head Start program services and 111 children received Head Start program services; 38,768 meals were provided to 755 seniors in Henry and Watertown through the 60's plus Dining Program; 60 families received utilities assistance; 13 families received security rent deposit assistance; 48 households served through the Volunteer Income Tax Assistance (VITA) program; 5 families received rental assistance to prevent them from becoming homeless; and staff made 297 referrals to help residents gain access to programs and services from partner agencies. ICAP will be involved with the Census in 2020 and encourage clients to respond to those gathering information. Cindy also briefed the Board on the Watertown Transitional Housing Program and housing assistance through the Brothers and Sisters Behind Bars Program.

FIRST DISTRICT ASSOCIATION OF LOCAL GOVERNMENTS ANNUAL REVIEW

Todd Kays, Executive Director with the First District Association of Local Governments, appeared before the Board to give an update on staff activities and economic development activities of the First District in 2019. Mr. Kays outlined who the First District is and services provided; Planning District work areas; counties located within the First District; make up of the First District's Governing body; FY2020 District funding; staffing levels; District results; and Codington County results (grants and business loans); FY2019 grants awarded; and FY2019 return on investment data. In Codington County, First District assists with: 911 GIS database management; E-911 addressing; GIS data set maintenance; GIS website maintenance; GIS parcel data; zoning services and development of zoning ordinance amendments; and development of the County's SD DOT Bridge and Highway Plan. First District provided GIS training to County and Municipal staff and other numerous services were provided to various entities within the

District. The Board expressed thanks for the continuing partnership between Codington County and First District.

PARCEL DATA BASE MAINTENANCE

Motion by VanDusen, second by Gabel, to authorize the Chair to sign a letter of agreement, in the amount of \$6,000.00, for services between Codington County and First District Association of Local Governments for the maintenance of the County's parcel data base; all present voted aye; motion carried.

GIS WEBSITE DEVELOPMENT AND HOSTING

Motion by Gabel, second by Waterman, to authorize the Chair to sign a letter of agreement, in the amount of \$3,100.00, with First District Assoc. of Local Governments., for the continued hosting and development of the GIS website for calendar year 2020; all present voted aye; motion carried.

MONTHLY REPORTS

Auditor, Cindy Brugman, updated the Board on nominating petitions, pay 2020 tax notices, preparation of 2020 County employee wage schedules, clearing out of the 2019 general ledger, and annual report preparations. Director of Equalization, Shawna Constant, updated the Board on the following: fielding phone calls from tax payers after pay 2020 tax notices were mailed; property tax splits, building permits, new assessments, and preparation for the printing and mailing of annual assessment notices by March 1st. Welfare Director, Sarah Petersen, provided the Board with a written report of statistics from the Welfare office for the month of October 2019. 34 people were served for the following: 1 transit, 1 misc., 10 utilities, 3 medical, 9 housing, 2 homeless, 4 ESG (Emergency Services Grant), 3 economic assistance, and 3 burials; there were \$5,970.00 in funds expended by the County for these contacts and costs in the amount \$12,216.00 were avoided by using other resources. The Welfare Director advised the Board a recent report reflects that in the State of South Dakota, a person who wants to rent a one-bedroom apartment would pay approximately \$15.00 per hour while the State minimum wage in 2019 is \$9.10 per hour. This makes it difficult for clients to make ends meet and still find suitable housing. Federal programs are available to qualified clients to make up the difference. Discussion was held regarding the number of rooms the County retains for homeless clients. The Welfare Director noted the County currently retains one room for this purpose unless an emergency ensues. Weed Supervisor, Steve Molengraaf, gave a video presentation updating the Board on his progress in identifying the right of way on County Roads. The Weed Supervisor also updated the Board on the following: Recertification classes are underway; working the booth at the Sioux Falls Farm Show on January 31st; working the booth at the Watertown Winter Farm show on February 15th; January 19th through January 21st State Weed and Pest Conference; and the local annual Weed meeting will be held on Wednesday evening, February 26th, at the Codington County Extension Center Complex.

2020 INDIGENT BURIAL RATES

Welfare Director, Sarah Petersen, recommended the following burial rates, for the indigent, in 2020: \$3,952.00 for a burial, \$2,575.00 for a cremation, and opening and closing of graves at the City of Watertown's current rate. Motion by Johnson, second by Gabel, to approve the 2020 burial rates as recommended by the Welfare Director; all voted aye; motion carried.

HIGHWAY DEPT. FREIGHTLINER TRUCKS

Highway Supt., Rick Hartley, informed the Board that the price of \$109,696.00 each, to purchase 3 Freightliner Trucks as budgeted for the Highway Dept. in 2020, did not include the cost of warranties. Motion by Gabel, second by Waterman, to approve the purchase of a 5-year warranty, for each truck, at a cost of \$2,450.00 each; all voted aye; motion carried. Mr. Hartley noted this amount was also budgeted for in 2020. Original action to approve the truck purchases was taken at the Board's meeting on January 7, 2020.
