The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, March 29, 2022, at the Codington County Court House. Commission members present were: Lee Gabel, Charlie Waterman, Myron Johnson, Troy VanDusen and Brenda Hanten; Chair, Brenda Hanten, presiding. Commissioner Hanten led the pledge of allegiance.

CALLS FOR PUBLIC COMMENT AND CONFLICT OF INTEREST ITEMS

Chair Hanten called for public comments to be taken up during the open portion of the meeting; none were offered. There were no conflict-of-interest items to note.

AGENDA APPROVED

Motion by VanDusen, second by Gabel, to approve the March 29th, 2022 agenda as posted; all voted aye; motion carried.

MINUTES APPROVED

Motion by Gabel, second by Johnson, to approve the minutes of March 22nd, 2022; all voted aye; motion carried.

REQUEST TO SELL ALCOHOL AT EXTENSION COMPLEX/BOYS & GIRLS CLUB EVENT

Kelly Jaderborg, Director of Development, with the Watertown Boys and Girls Club, met with the Board to request authorization to sell alcohol during the Blue Door Derby Camel Races event, scheduled for April 29th at the Codington County Extension Center Complex. A liquor license will be transferred following proper procedure for this event. Motion by VanDusen, second by Gabel, to approve this request; all voted aye; motion carried.

MONTHLY REPORTS

4-H/Youth Program Advisor, Jodi Loehrer, updated the Board. Shooting sports will continue for 4 more weeks with the State Shoot scheduled for April 22nd, 23rd, and 24th, in Ft. Pierre. Jodi will be hosting the North District 4-H Advisors at a networking day on March 30th. Virtual Kids Care is being held on Mondays via Zoom, 49 youth are signed up for the 4-H At Home Project in April, the 4-H Teen Regional Dash event is scheduled for April 30th and again sometime in October, and planning for summer opportunities, that have been on-hold for the past two summers, is underway.

DAILY OUT-OF-COUNTY INMATE RATES

Motion by Gabel, second by Hanten, to set the daily rate, for housing of out-of-county inmates, at \$95.00 per day, effective April 1, 2022, and per the recommendation of Sheriff, Brad Howell, all voted aye; motion carried.

OUT-OF-COUNTY INMATE CONTRACTS

Motion by Gabel, second by VanDusen, to approve contracts with Clark, Deuel, and Hamlin counties for the housing of inmates from those counties in the Codington County Detention Center; all voted aye; motion carried.

HELPLINE CENTER NETWORK OF CARE PARTNER AGENCY M.O.U.

Motion by Gabel, second by Johnson, to approve an M.O.U. between Codington County and the Helpline Center Network of Care; all voted aye; motion carried. This M.O.U. was previously approved on October 26th, 2021, but due to a change in language regarding Article 10, Liability, the M.O.U. required a final adoption at this time. Welfare Director, Sara Foust and Nicole LaVallie, Community Care Coordinator, were present for this action.

CHANGE IN MEETING DATE

The Board noted they will not meet on Tuesday, April 5th, 2021, due to a lack of an available quorum.

EASTER LEAVE

The Board noted the Court House and all County offices will be closed on Good Friday, April 15th, and Easter Monday, April 18th, per previously adopted policy.

UNCOLLECTIBLE AIRFLIGHT PROPERTY TAX

Treasurer, Carol Maloney, presented the Board with information pertaining to Air Flight property taxes with two years of delinquent taxes, payable in 2019 and 2020, in the amounts of \$11,543.02 and \$10,945.11 respectively. The Treasurer advised the Board that the Sheriff's Office, Civil Process Deputy, has spent extensive time in an attempt to locate the property owners responsible for payment of these taxes, to no avail and is unaware of anything that could be used to levy and sell in an effort to satisfy the distress warrants issued for the collection of these taxes. The Civil Process Deputy has recommended that the County Treasurer declare these taxes uncollectible. The Treasurer requested the Board take action, at this time, to declare the aforementioned taxes uncollectible and removed from the collection process. Motion by VanDusen, second by Gabel, to declare the aforementioned property taxes, totaling \$22,488.13 uncollectible; all voted aye; motion carried.
