February 14, 2023

The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, February 14, 2023, at the Codington County Court House. Commission members present were: Lee Gabel, Charlie Waterman, Myron Johnson, Troy VanDusen and Randall Schweer; Chair Gabel, presiding. The pledge of allegiance was led by Commissioner Waterman.

#### CALLS FOR PUBLIC COMMENT AND CONFLICT OF INTEREST ITEMS

Chair Gabel called for public comments to be taken up during the open portion of the meeting; none were offered. There were no conflict-of-interest items to note.

#### AGENDA APPROVED

Motion by VanDusen, second by Schweer, to approve the agenda for February 14, 2023, as posted; all voted aye; motion carried.

#### MINUTES APPROVED

Motion by Johnson, second by Waterman, to approve the minutes of February 7, 2023; all voted aye; motion carried.

#### MONTHLY REPORTS

Auditor, Cindy Brugman, updated the Board: the annual report for 2022 is near completion; abatements and tax splits are being processed; and 2024 Budget preparation will be starting in the near future.

Director of Equalization, Shawna Constant, provided the Board with printed reports regarding property tax relief programs, property assessment appeal processes; and understanding the property tax process. Assessment notices will be mailed by March 1st to property owners. County and Consolidated Boards of Equalization will begin on April 11th, 2023. Welfare Director, Sara Foust, updated the Board: 23 unique individuals were served in January; CARES/ERA - \$3500 was received for administrative fees; ICAP Case Management – averaging around 10 hours per week; a Community Health Worker employee started on February 1st, on a part-time basis at this time; the Medicaid reimbursement process continues to be studied and discussed; the Watertown Cares Board is planning to start interviews for the Executive Director position; a training on "helping the Community" will be sponsored by CASA on February 24th; the SDACWO will meet on April 13 & 14; an Interagency networking meeting was held with 22 in attendance; the Strategic Planning Advisory Council will meet on February 27th; and an awareness day for businesses and community will take place on April 18th with a poverty simulation and announcements regarding resilient communities.

#### ODNEY CONTRACT FOR WEB SITE DEVELOPMENT FOR SOCIAL SERVICES ADVISORY

Welfare Director, Sara Foust, presented a contract to the Board, with ODNEY, for the development of a web site for the Social Services Advisory Council utilizing funds allocated from the Dept. of Health, Health Improvement Innovation Grant. Motion by VanDusen, second by Watertown, to approve the contract with ODNEY; all voted aye; motion carried.

#### WELFARE OFFICE CLOSURE

Motion by Johnson, second by Schweer to authorize the closing of the Welfare Office, on February 24<sup>th</sup>, from 8:30 a.m. to 12:30 p.m., to allow the Welfare Director and office employees to attend a training; all voted aye; motion carried.

# RESOLUTION 2023-05 BRIDGE REINSPECTION PROGRAM RESOLUTION FOR USE WITH SDDOT RETAINER CONTRACTS

<u>WHEREAS</u>, 23 CRF 650 Subpart C, requires initial inspection of all bridges and reinspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

<u>THEREFORE</u>, Codington County is desirous of participating in the Bridge Inspection Program using Bridge Replacement funds.

The County requests SDDOT to hire Banner Associates, Inc. (Consulting Engineers) for the inspection work. SDDOT will secure federal approvals, make payments to the Consulting Engineer for inspection services rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.
