The Codington County Commissioners met in regular session at 9:00 a.m., Tuesday, May 16, 2023, at the Codington County Court House. Commission members present were: Lee Gabel, Charlie Waterman, Myron Johnson, Troy VanDusen, and Randall Schweer; Chair Gabel, presiding. The pledge of allegiance was led by Commissioner Gabel.

### CALLS FOR PUBLIC COMMENT AND CONFLICT OF INTEREST ITEMS

Chair Gabel called for public comments to be taken up during the open portion of the meeting; none were offered. There were no conflict-of-interest items to note.

### AGENDA APPROVED

Motion by VanDusen, second by Schweer, to approve the May 16, 2023 agenda, as posted; all voted aye; motion carried.

### MINUTES APPROVED

Motion by Johnson, second by Waterman, to approve the minutes of May 09, 2023 as presented; all voted aye; motion carried.

### MONTHLY REPORTS

Facility Manager, Steve Molengraaf, provided the board with a written report, Ag. Building – meetings, auctions, minor events; Court House – Will be presenting quotes for the carpeting on second floor courtrooms and adjacent rooms in the next couple weeks; Detention Center – waiting for the lavatory and toilets to arrive for installation; Park – reservations for this year as of April 24th, 2023 is \$47,840.00, 531 reservations total since February 1st, 2023, the insurance company is reviewing the estimate charges for the park shop water damage; Weed - equipment is being prepared for the upcoming spraying season. Highway Superintendent, Rick Hartley, informed the Board that the guys have been busy pulling shoulders on the County gravel roads getting the roads back into shape, the County gravel roads are taking a beating right now and some of the frost boils are very bad, the guys have been busy with blow outs that have also occurred on the County asphalt roads, load limits are still on at this time and will remain on until the conditions are favorable to remove them, every low spot in the County road system that has water by it is extremely soft, the guys are still working on crack sealing the County asphalt roads; the paint stripers will be back to finish the fog lines on the chip seal roads from last year, they should be here at the end of this month or the first part of June, County Roads 3,7,9 and 20 are the roads that they will be painting and are all located east of State Highway 81 and south of Highway 212, the guys have been sweeping these roads to prepare them for the painters; Mark Junker will be starting the bridge inspection shortly, this summer he will be doing ½ of the bridges; the Highway Dept. will be working with the Emergency Management Office with the Disaster Declaration it appears there may be enough damage from the spring flooding, while the County received minimal damage in 6 locations which amounted to 9100 ton of gravel. 4-H Youth Program Advisor, Jodi Loehrer, reported: they had the first consumer decision making and horticulture skillathon last week and will be having another one on Thursday, May 18th, 2023, this qualifies kids for the state contest, along with the Youth Quality Care of Animals for the livestock youth; held a shooting sports awards night and drew the raffle winners; this week is the Optimist Club, Extension Service and Police Department Bike Safety Inspections that is coordinated with the schools, started at Mellette School yesterday with 21 youth and today is McKinley, also received a donation of helmets from Highway Safety that will be given away also; teaching Junior Achievement, Financial Literacy, to 3<sup>rd</sup> grade youth at McKinley School; had horse safety at Joy Ranch and held a dog meeting and will start dog classes in a few weeks, Special Foods workshop for youth at the end of the month; 4-H Camp dates this year are June 5,6 & 7, at the Lake Poinsette Methodist Camp with 24 campers going and Jodi's daughter will be a camp counselor for her second summer.
