The pledge of allegiance was led by Commissioner Schweer.

CALLS FOR PUBLIC COMMENT AND CONFLICT OF INTEREST ITEMS

Vice-Chair VanDusen called for public comments to be taken up during the open portion of the meeting; none were offered. There were no conflict-of-interest items to note.

CULVERT REPAIRS FOR COUNTY HWY 6

Motion by Johnson, second by Gabel, to accept quote B, in the amount of \$66,997.00, from Basin Construction, due to the fact that this is an emergency project it is not a budgeted item, Mark Junker, Engineer with Banner Associates, Inc. and Rick Hartley, Highway Supt. presented to the Board 4 different quotes for this project, this will be added for FEMA reimbursement, and the State FAS Roads for ER Funding; all voted aye; motion carried.

MONTHLY REPORTS

Auditor, Brenda Hanten, updated the Board: Continue to work on the 2024 Provision Budgets; the Auditor's Office is open today from 7 a.m. to 7 p.m. due to the Special Election being held in Henry; will be holding a Public Test for the Watertown City/School Election @ 8:30 a.m., to test their ballots; next Tuesday, June 20th, 2023 is Election Day for the Watertown City/School Election at the Civic Arena, the Auditor's Office will be open 7 a.m. to 7 p.m. to assist with any voter questions they may have and will also be using the scanner to count their ballots that evening. Welfare Director, Sara Foust, updated the Board: 20 unique individuals were served in May; CARES/ERA - \$4000 was received for administrative fees; ICAP Case Management - averaging around 10-12 hours per week; the IMPACT/ Community Health Worker -Paige, Kari, & Sara attended the Annual Conference is in May, received approval for Kari to become a certified CHW which she will enroll in the program in the fall semester, working on Medicaid certification; the Watertown Cares Board closed on the 612 Flats on May 23rd, 2023, renovations are in progress, hoping it will be ready for clients in the next month; extend the contract with Angela, will continue looking for grant funding to support this; travel requests, ACEs training & Resilient Community networking SD Housing Annual Conference; have new signage on the windows at the Welfare Office; Systems of Care/Strategic Planning, Codington Connects – Agency of the Month is the Watertown Police Department; Interagency Meetings – decided not to have June & July meetings; Department of Health Improvement Innovation Grant Funds to be used to maintain Codington Connects for additional web site support and a Community Needs Assessment; Housing Action Team is meeting June 26th, 2023 via zoom to meet with representatives from Codington County, 13 June 2023

Rapid City One Heart to learn about innovative housing assistance program and their Director of the Rapid City Community Foundation who leads the Collective Impact Program involved with leading a lot of their housing initiatives; Child care group is looking at how to expand the availability of child care; Event Planning group is putting together a 3 year training plan to have a timeline; Communication Group is working on web site, the Codington Connects and community events.

HEALTH IMPROVEMENT INNOVATION GRANT APPLICATION

GRANT APPLICATION FOR R/ED RECEPTION CENTER GRANT FUNDS

Louis Canfield, Director of Youth Diversion, Watertown Boys and Girls Club, presented the Board with information to apply for and request the County's support to apply for the R/ED Reception Center Grant with a grant opportunity with the Department of Corrections in the amount of \$20,000.00, this is a court approved diversion program and there will not be any County match dollars and the funds will not run through the County. The first half of the grant year will be used to research other counties that have Reception Centers and best practices and the second half of the grant year would be to contract with organizations willing to be partners. Codington would be an on-call Reception Center; Motion by Gabel, second by Schweer to approve

supporting the JDAI program to submit the R/ED Reception Center Grant Application; all voted aye; motion carried.

BURN BAN DISCUSSION

The board held a brief discussion regarding whether to enact a burn ban. Cheri Howell, Assistant Emergency Manager, reported that she had conversations with the Fire Chiefs in the County and they are not recommending a burn ban at this time.

CANCEL VISION PLAN

Motion by Johnson, second by Schweer to cancel the County's current vision plan with Avesis and change the County vision plan to VSP with Kranz Insurance, Human Resource Associate, Natalie Remund, informed the Board that this was an employee driven request and the current vision plan didn't provide enough coverage and were looking for expanded benefits, been working on this for several months, had representatives from different companies come in and present and have an open forum to give employees an opportunity to ask questions, sent out an employee survey with the different plans and options and what would their choice be, the results of the survey the majority of the employees voted to make a switch to the VSP Plan offered through Kranz Insurance that offers 2 options, one will be a basic plan that is comparable to what the County currently has or employees that would like expanded coverage will have that option also, the vision plan is 100% employee paid but needs the Board to approve it in order for employees to receive discounted rates; all voted aye; motion carried.






